Background

During the 10th International Dialogue on Population and Sustainable Development, the participants, specifically the youth representatives, emphasized the importance of employment, income generation and youth participation. The topic of the 11th International Dialogue on Population and Sustainable Development will take this into account and will at the same time ensure continuity with last year's conference.

Today's generation of young people is the largest ever. Children and youth below the age of 25 years amount to 43 per cent of the world population. Of these, 1.2 billion are young men and women between the age of 15 and 24, the typical age for entering the labor market. Many low- and middle-income countries, especially in Asia and Africa, are in the second phase of the so called demographic transition, which is characterized by decreasing infant mortality rates, and increasing life expectancy. Given the right kind of policy environment, young people can play a central role for the development of their communities and societies. A rising adolescent and youth share of the population (demographic bonus) offers a time limited window of opportunity for economic and income growth, poverty reduction and sustainable social development that converts the 'demographic bonus' into a 'demographic dividend'.

Young people have a great potential for development, however they are disproportionally affected by numerous development issues, also addressed by the Millennium Development Goals (MDGs) and the Rio+20 outcome document. Youth employment is a topic that is gaining increasing momentum, not at least because of the political and social developments in Northern Africa and the Middle East but also because of the drastic increase of youth unemployment in European countries, such as Spain or Greece. Globally youth unemployment is rising both in richer and in poorer countries. Meanwhile, 200 million people, over 75 million of them youth, are unemployed and actively looking for work. Beyond that, the majority of workers in developing countries are trapped in informal and vulnerable jobs with meager income.

For a country to reap a demographic dividend through its young and rapidly growing potential workforce, the government has to establish labor policies that create jobs for

them in the public as well in the private sector to put them in productive employment. Economic growth is a prerequisite for job creation but it requires targeted strategies implemented by government and business leaders to spur growth in sectors with the greatest job creation potential. Employment opportunities must be opened up as early as possible to offer young people, especially women, a prospect in life. However the challenges young people face to enter the labor market are manifold, reaching from educational and health challenges, to challenges concerning the labor market structure, labor policies and politics, as well as challenges concerning the cultural setting of society.

Besides creating the right type of jobs, it is important to harness the demographic dividend through the implementation of economic policies and good governance, the empowerment of girls and women and investments in the quality of education including comprehensive sexuality education and health systems as well as social protection schemes. They contribute to the overall well-being of the population and specifically of young people and are essential for promoting and protecting their human rights and empowering them to lead self-determined, fulfilling and productive lives. With this they also contribute to a healthy and productive workforce.
